I say that the Mrs. Rangoli Chandel on 15 / 04 / 2020 at around 4.37 pm had shamelessly made a highly immature, irresponsible, objectionable, malicious, defamatory statement / tweet on her twitter account id @Rangoli\_A stating that "A Jamati died of Corona when police and doctors went to check their families they were attacked and killed, secular media, make these mullas + secular media stand in a line and shoot them dead... f\*\*\*\*k the history they may call us nazis who cares, life is more imp than fake image." Hereto annexed and marked as EXHIBIT A is the screenshot of the said malicious tweet made by the Mrs. Rangoli Chandel
- 5. I say that immense outrage and hate were followed amongst various sects, followers, communities, celebrities, politicians after the said statement was delivered by Mrs.

Rangoli Chandel and thereafter the social media giant Twitter after having received unaccountable complaints and reports on the twitter handle for her illicit tweet immediately took strict action and suspended the official verified and highly influential twitter account within a day.

- 6. I further say that thereafter within few days, the Kangana Ranaut shamelessly came out in support of her Sister Mrs. Rangoli Chandel (which she is always known for doing whenever the accused no.1 sparks controversy and vice-versa) and stoop even further low, crossed all the legal limits and constitutional values and posted a short video on 18/04/2020 on various social media including Instagram account of Rangoli Chandel being 'rangoli\_r\_chandel' where she has not just supported the malicious tweet, acts of her sister but also went one step ahead and called a sect of Muslims (Jamati) as Terrorists! And also spoke malice about them.
- 7. In the said malicious video which the Kangana Ranaut posted against the Muslims in the support of the malicious hateful tweet statement of her sister Mrs. Rangoli Chandel; At first she is seen supporting her sisters hate tweet against Muslims calling for their killings, then she spoke ill about the Jamati Muslims, later she takes the several names of ministers unnecessarily to show her political influence and then very specifically said that "Aap Aatankwadiyo ko Aatankwadi nahi keh sakte?" which is nothing but extreme hate, deceitful, derogatory statement against the Muslim Community even if the same was against the Jamati Muslims, the same cannot be justified by any means. Hereto annexed and marked as EXHIBIT B is the screenshot of the said illicit video made by the Kangana Ranaut
- 8. It is pertinent to note that one sister calls for genocide killings, violence and the other sister not just shamelessly support her for the same despite nationwide criticism and

suspension of her twitter account but also gives a label of TERRORIST to a sect of Muslims and also unnecessarily drags the respectful government servants in the shameful video act to give it a severe communal angle by misusing their stardom, fan base, fame, money, power, influence with an aim and intent to promote hatred, misbalance, fights in the country for their personal benefits and gains.

- 9. I say that both the sisters have now stooped even low by misusing their fan base, fame, power, influence through their social media accounts and creating hatred, enmity amongst religions in India through their above said tweet and video with an aim and intent to garner cheap publicity, personal gains and benefit by taking undue advantage of the grave situation prevailing in India due to Pandemic CoronaVirus which has already taken lives of many and still counting.
- 10. I say that the Central and the state governments are already taking necessary action in order to stop the spread of Pandemic Corona Virus; Whereas unscrupulous individuals like Rangoli Chandel are spreading Extreme hate and promoting genocide, killings, violence against the muslim community and even provoking to take law in hands by shooting them.
- 11. I say that after the illicit tweet made by the Mrs. Rangoli Chandel, I immediately filed a Police complaint before the Amboli Police Station on 16/04/2020 and requested the concerned police to forthwith register FIR against the Mrs. Rangoli Chandel; Thereafter when the Kangana Ranaut made the abovementioned illicit video, I further lodged a fresh complaint against the Kangana Ranaut as well dated 22/04/2020 to Register FIR; Hereto annexed and marked as EXIHIBIT are the copies of the Police complaints filed against both sisters.

I say that Ms. Kangana Ranaut has now crossed all her limits by even questioning the credibility, caliber, hard work, dedication of the Maharashtra and Mumbai Police by yet again wrongfully putting allegations on them leveling them as well behind the sad demise of the late actor stating that they are allegedly supporting the self claimed murder / death of the said late actor.

I say that Ms. Kangana Ranaut has now stepped above the law and have called the economic capital of India and its pride i.e. the MUMBAI city as 'PAKISTAN OCCUPIED KASHMIR' using her verified twitter handler @KanganaTeam on 03/08/2020; The accused using her power, fans, followers have been continuously tarnishing the image and reputation of the country and its part, thereby have now started calling and levelling it with our enemy country for her personal benefits and gains. It is pertinent to note that the said malicious tweets have defamed our country, its police, authorized government bodies, executive machineries all being established by the laws in India and have created serious ruckus in the country which has not just hurt my feelings but also have hurt the emotions and feelings of the MUMBAI POLICE, its retired officers, Mumbaikars, Maharashtrians and all the fellow Countrymen. The Kangana Ranaut has been continuously creating fear and panic in

It is further also categorically stated that recently a private complaint under section 156(3) of CRPC was been filed against Kangana Ranaut before the Magistrate Court at Bandra, Mumbai for creating and atmosphere of hate in the country by defaming the Bollywood industry. After which the learned magistrate court ordered necessary action and Investigation vide order dated 16/10/2020. Hereto annexed and marked

- 22. I say that after the several illicit tweet made by the accused no.1, I immediately filed a Police complaint before the Andheri Police Station on 04/09/2020 and requested the concerned police to forthwith register FIR against the accused; the concerned police station even took my statement within few days but till date no action has been taken against the accused despite the offences being serious in nature. Hereto annexed and marked as ANNEXURE H is the copy of the Police complaint filed against Kangana Ranaut.

- 25. Also tweet of Ms. Kanagana Ranaut which is above mentioned shows mala fide intentions and ulterior motives creating the hatred atmosphere in the country amongst the Hindus and the Muslims, thereby causing serious threat to the integrity of the country.
