IN THE CHAIR: MR. KAILASH VASDEV, VICE PRESIDENT.

The Executive Committee accepted the resignation unilaterally sent by the Election Committee of Mr. Jaideep Gupta, Mr. Harin P. Raval and Mr. Nakul Dewan on 15th January 2021. The Committee expressed its gratitude to the Election Committee for undertaking the difficult task of holding elections in this year of the pandemic.

As the Election Committee had resigned, steps to be taken for holding of the elections were discussed by the members.

After extensive deliberations it was resolved as follows

1. Elections to the Supreme Court Bar Associations for the year 2020-2021 should be held by the third week of February 2021. For this purpose an Election Committee be appointed from amongst members of the Supreme Court Bar Association after due consultation with the members of the Executive Committee. Each Executive Committee member is requested to propose names for appointing members to the Election Committee. The Election Committee would be appointed after obtaining the prior confirmation of the Executive Committee.

- 2. The elections would be preferred to be held in hybrid mode as there was an extensive request from members for this. The Elections should be held inside the Supreme Court premises in a phased and staggered manner as may be found appropriate by the Election Committee. Necessary permission for holding such an election would have to be obtained from the Hon'ble Chief Justice of India top hold the election in this mode. RESOLVED that an urgent request to that effect be made immediately for this purpose to the Hon'ble Chief Justice and this decision be communicated to the Election Committee.
- 3. All expenses for holding of the election including the costs for online voting would be borne and paid by the Supreme Court Bar Association as soon as the bill of costs was is received from the Election Committee which was to appoint such an agency.
- 4. The members resolved that a meeting be held between the Hon'ble Chief justice and members of the Executive Committee to request to commence physical hearing of all cases in the court halls.

The meeting ended with a vote of thanks to the chair.
